- Integrate the High Risk Infant program into wider DECD early childhood approaches and practices
- Promote and extend the implementation of SDM® as a tool for supporting quality practice and informed decision making in line with organisational priorities
- Facilitate the establishment of quality child protection practice, systems and services to enable children to be safely reunified with their parents
- Further strengthen Adverse Events program and facilitate the learning gained from the reviews into care and protection practice
- Strengthen interagency services and practice approaches to child protection.

The Courts Interface Team

The Courts Interface Team will contribute to the achievement of the Directorate vision by improved outcomes for children and families involved in all court processes through;


- Further development of all responses to courts.
